- Associated businesses for marketing purposes
- Companies providing information and infrastructure systems to us
- Representatives like finance brokers, lawyers, and accountants
- Any entity with your consent
- Entities as required by law, such as under the Anti-Money Laundering and Counter-Terrorism Financing Act 2006 (Cth)
- Investors, agents, or advisors interested in our business
- Your employer, referees, or identity verification services

Before disclosing your personal information, we ensure that the recipient has a commitment to protecting your information or that you have consented to the disclosure.

International Disclosure of Personal Information

We may disclose your personal information to related bodies corporate and third-party suppliers overseas. These disclosures may occur in countries including the Philippines and the USA. While these countries may not adhere to Australian Privacy Principles, we take reasonable steps to ensure your information remains protected.

Direct Marketing

We may use your personal information to keep you informed about finance options, offers, organizational changes, or new products and services. You can opt out of receiving marketing information at any time by contacting us or using the unsubscribe function in emails.

Updating Your Personal Information

It's crucial that the personal information we hold is accurate and up to date. Please inform us of any changes to your information. You can contact us to update your personal information.

Access and Correction of Personal Information

You have the right to access the personal information we hold about you. We may charge a fee for retrieving and supplying this information. Requests are usually addressed within seven days. If any information is incorrect, you may request correction, and we will respond within 30 days.

Using Government Identifiers

We do not use or disclose government identifiers like your tax file number, except as required by law. We will not use these identifiers to identify you.

Business Without Identifying You

Where lawful and practicable, you may conduct business with us without providing personal information, such as making general inquiries about interest rates or promotions.

Sensitive Information

We only collect sensitive information with your consent. Sensitive information includes

details about your racial or ethnic origin, political persuasion, memberships, sexual

preferences, criminal record, or health.

Security of Your Personal Information

We take reasonable steps to protect your personal information from misuse, loss, and

unauthorized access, modification, or disclosure. Information may be stored in both

paper and electronic forms.

Complaints

If you are dissatisfied with our handling of your personal information or have a complaint

about our compliance with the Privacy Act, please contact us. We will acknowledge your
